8. **Federal Government Unclaimed Financial Accounts** – Legislation was amended late last year, it's now perfectly fine for the balance of any bank account that hasn't been transacted on in as **little as three** years to be seized by the Commonwealth. Previously, the legislation had specified a minimum of seven years before the funds could be transferred to the government. ***Transactions such as interest paid or fees charged are automatic***, and therefore don't count as activity on an account. Customers will need to make a deposit, withdrawal or transfer in order to activate dormant accounts.
